

Here is a Cabinet Office list dated the 26 August, 2010, of quangos and other public bodies to be axed or merged by the coalition government, which was obtained by BBC One's Politics Show.

It includes a letter from Cabinet Office minister Francis Maude to Deputy Prime Minister Nick Clegg outlining the proposals. This is not a final list - negotiations are still ongoing about which bodies are to be axed.

Annex C - supplementary background information

Appointments

I am requesting that, where a body is to be abolished or a decision is still to be reached with me about its future, departments should consider carrying a vacancy in the case of board appointment or, in the case of chairs and deputy chairs where there may be a more pressing need to appoint, that departments either extend existing appointments, appoint on an interim basis, or temporarily appoint from within the existing board. Where this is not possible and a department considers that there is a business critical or statutory need to make an appointment outside of these parameters, then I expect departments to consult with my office and the Propriety and Ethics Team in Cabinet Office before proceeding. Appointments to the Board of bodies I have already agreed to be retained can go ahead in line with normal procedure.

In any situation departments should ensure contracts adhere to our general principle that we do not pay compensation or offer any other payment to public appointees in cases where boards and bodies are being wound up. In addition, where departments are proposing to extend an existing appointment, to re-appoint for a third term; or to promote or appoint from within existing board membership, you must consult the Office of the Commissioner for Public Appointments and secure the necessary approvals.

Equalities and fairness bodies - narrative

It is vital that government has a strong narrative about the way in which reforms to bodies with an equalities or fairness remit are aligned to government commitments in this area. I propose the following articulation:

- Improving Ministerial responsibility for equalities and fairness issues: The package of
 reforms is aimed at increasing accountability and, in a number of cases, we are aiming
 to do this by bringing functions previously carried out by arms length bodies into
 departments. This reflects the importance placed on equalities and fairness by the
 government and the reforms ensure that Ministers in future take direct responsibility
 for decisions on these issues rather than placing them at arms length.
- Improving the performance of the public equalities and fairness landscape: The
 landscape of public bodies operating in the equalities and fairness space is overly
 complex, diffuse and difficult for citizens to navigate. We are streamlining and
 simplifying this landscape to improve clarity and to ensure that those bodies we do
 retain are strongly focussed on the activities that matter most. Reforms to many of
 these bodies will ensure that they are not distracted by numerous other responsibilities
 and can carry out their functions in a more accountable way.
- <u>Policy context</u> This reform programme sits within a broader policy context, set out within the Programme for Government, and embedded in departmental structural reform plans.
- Economic choices: There is a need across activities to meet the challenge presented by a tighter fiscal position and we need to make hard choices about what we can sustainable afford.
- Implementation: We are seeking agreement from HAC in principle for reform of the bodies in this package. Discussions on implementing the changes will allow us to consider detailed proposals for how functions should be carried out going forward.

This means we can consider how we replace bureaucratic accountability with democratic accountability, particularly through the mechanism of greater transparency. We can also consider what should be done within departments, and where we can support the Big Society objectives by encouraging citizens or the voluntary sector to play an increased role in engaging more directly in equality and fairness issues. Proposals will also be subject to an equalities impact assessment

Scientific advisory committees

The public bodies review has identified that some bodies, particularly those providing advice on very specific issues or on a time limited basis, could be run more efficiently as 'expert scientific committees' that operate independently of departments or which are reconstituted on a short-term basis and/or with new membership. Cabinet Office officials can work with departments to support this restructuring.

In order to ensure reforms are carried out in accordance with the Principles of Scientific Advice to Government, I propose that where departments consider reconstituting bodies as expert scientific committees, they seek to put in place the following safeguards. This approach has been agreed with the Minister for Universities and Skills and with the Government Chief Scientist:

- Expert scientific committees must be set up, recruited and provide independent advice in line with the government's Principles for Scientific Advice and CoPSAC (the Code of Practice for Scientific Advisory Committees)
- Escalation routes in place to ensure advice from expert scientific committees can be submitted directly to Ministers, as appropriate.
- For departments who are significant users of science and/or have a large number of expert scientific committees or other science advisory bodies that it is good practice to have an overarching departmental Science Advisory Council with oversight of all such scientific advice bodies.

Ongoing governance and review

I have already extended many existing controls and requirements to NDPBs, put in place a new pay approval process to control top pay, and am in the process of introducing new pay disclosure and transparency measures for senior staff. In addition, the Cabinet Office will in the New Year (after consultation with departments) be issuing new guidance for departments on NDPBs – which will require a more robust challenge of proposals to set up new NDPBs, a tighter control framework for managing NDPBs and more transparent and regular reviews of NDPBs, with greater central oversight. I will also be working with the Liaison Committee and the Public Administration Select Committee to strengthen select committee scrutiny of public bodies and of appointments to the boards of public bodies.

PUBLIC BODIES REFORM - CLEARANCE FROM HOME AFFAIRS

The coalition has committed to making substantial reforms to public bodies, including reducing their number and cost, with the aim of substantially increasing accountability across all activities of the state, i have been asked by the Prime Minister to lead this programme, working closely with Cabinet colleagues.

This letter therefore seeks Home Affairs clearance to a package of abolitions, mergers and other reforms to public bodies, details of which are set out in Annexes A and B. It also seeks agreement to proposals for dealing with the cross-outting issues that have arisen during the work so far, and for which we will need a consistent approach as we implement these reforms.

These reforms are intended primarily to increase accountability, but will also support the aims of the Spenting Review by reducing costs and support our ambitions for a Big Society by encouraging alternative, devolved or non state delivery models. I would be grateful for responses by 7 September.

Summary of proposals

I have been working with colleagues to agree the reforms each department will introduce. This paper sets out current reform proposals, including the bodies which are to be retained, and a series of related implementation issues. The current package of reforms is set out in <u>Annex A</u> (a summary of the overall position) and <u>Annex B</u> (a detailed list of bodies), with additional information at Annex C.



Colleagues have made good progress in assessing and agreeing reforms to their public bodies. The overall package represents a substantial set of reforms which go a long way to realising the Government's objectives for increased accountability and reductions in the number of public bodies as well as reducing the costs of these bodies to the taxpayer.

For some bodies, discussions with the relevant Secretary of State are still underway, or a departmental review of that body is in process. It is important that colleagues seek resolution on those bodies in early September so that we can include any required legislative measures within the Public Bodies Bill where possible, and I have written to secretaries of state to encourage swift progress on this issue. Where it has not been possible to reach agreement. I intend to chair an informal ministerial 'star chamber' to resolve those discussions in early to mid September, writing again to Home Affairs Committee at that stage to seek clearance for the star chamber's recommendations.

In summary, the reform package currently comprises.

- 180 bodies abolished as public body
- 124 bodies merged with another body
- 56 bodies retained but subject to substantial reform
- 282 bodies to be retained
- 100 bodies still to be agreed because final discussions or a departmental review are underway.

This means that, as it currently stands, 24 per cent of bodies are being abolished or will no longer be a public body, 17 per cent are being merged, and 8 per cent are being substantially reformed. In total 49 per cent of all the these bodies will be radically reformed, and this is likely to rise following final decisions.

Please note that some of these bodies have already received Home Affairs clearance where agreement was sought early as part of a wider policy initiative, or are currently the subject of a write-round. These are marked in Annex B with an asterisk. There may be a further separate write-round on some proposals.

The Committee is asked to agree in principle the reform decisions, accepting that implementation will require legislative powers in many cases and further departmental implementation planning.

For bodies that are to be retained, it is important to highlight that in many instances secretaries of state are still committed to substantial reforms over the medium term. I am also strengthening the Government's ongoing monitoring and review requirements for public bodies to ensure that they are accountable and transparent and that we have more robust controls in future over their creation and retention.

Communications and announcements

It is vital that we plan for the substantial communications implications of this reform programme. Several departments have already made announcements relating to their public bodies and, whilst this has been helpful in order to set

the reforms in context and to publicly demonstrate progress. I have now agreed with the Prime Minister that there should be no further announcements until we have reached collective agreement on the package of reforms. This means that in September I should be in a position to make an overarching, contextualising announcement about the reforms programme which departments can then follow with more detailed announcements about their respective reforms. It is important that announcements are sequenced in this way, and that they reinforce our main objective in this work, which is to increase the accountability of state activities.

Handling appointments to public bodies

Between now and the implementation of reforms there will be instances of vacancies arising on the board of a public body. Whilst in some cases it will be necessary to fill the position to meet a statutory requirement or provide leadership during a transition period, this should be avoided if at all possible and the primary principle should be to minimise costs to the taxpayer. The Cabinet Office will therefore be amending the process for making appointments to public bodies, ensuring more central coordination in future. More details can be found in Annex C.

Devolved Issues

A number of these proposed changes affect public bodies that operate within the devolved administrations, and there are also potential opportunities being explored for further rationalisation of the public bodies landscapes within the devolved administrations. Devolution is therefore a key consideration for the reform programme and for the Public Bodies Bill.

Cabinet Office officials are supporting departments in discussions with the territorial offices and the devolved administrations, but it will be very important that individual departments write to their counterparts in other administrations to advise them on the details of any proposed reforms and work with the devolved administrations to support rationalisation of public bodies in Scotland, Wales and Northern Ireland.

Local / geographic impact

We need to take a proactive approach to managing the local impact of reductions in employment arising from this reform programme, particularly (but not exclusively) in those areas outside London and the South East.

My officials are working with CLG and other departments to understand possible reductions by local authority area, and I will include recommendations resulting from this analysis in the further write round to Home Affairs Committee. Departments will need to consider how to support geographical areas that are disproportionately affected, for example through relocation programmes, phasing of reductions, and complimentary economic development and employment programmes. They may also wish to consider the role of the Regional Growth Fund, proposals for which are currently out to consultation.

Cross-cutting issues and impact on types of public body

Cabinet Office officials are continuing to work with yours to review the emerging landscape and address the cross-cutting issues that arise from this work. There are both opportunities and challenges associated with developing a more coherent approach, such as the chance to have a consistent approach to different types of pubic body that exist across government.

Scientific advisory committees

The Government is committed to evidence-based policy making and to the Principles of Scientific Advice to Government which are now enshrined in the Ministerial Code Cabinet Office has been working with the Chief Scientist and Government Office for Science and other departmental colleagues to identify whether there are more accountable and effective ways to secure the delivery of independent, high quality scientific advice to government which ensures we can both deliver the objectives of public bodies reform programme, and meet the Principles of Scientific Advice. A proposed approach has been agreed with the Minister for Universities and Skills and with the Government Chief Scientist, and is included in Annex C. I would be grateful for your agreement to these principles.

Pay Review Bodies

Government values the expertise and independent role of Pay Review Bodies and therefore, in the context of the upcoming spending review and existing pay restraint, although they have been included within the scope of this review no changes are proposed (this is with the exception of the School Support Staff Negotiating Body, in recognition that this workforce is not best served by such a national approach to pay and reward negotiations).

Regulators

Many bodies performing a regulatory function are NDPBs and have been included in the scope of this work, and reforms have been proposed to these bodies where this is appropriate.

Whilst there had been discussions as to whether the Public Bodies Bill could be used to impose sunset clauses on regulators, I am keen to ensure that the scope of the Bill remains focused on public bodies. I therefore propose that this Bill is not the most appropriate vehicle, but that we consider alternative approaches. This could include a separate legislative vehicle, but in the meantime I suggest that we take a consistent approach to the ongoing governance and review of all bodies, making use of a strengthened governance framework (discussed in more detail below) and considering how we could use the Public Administration Select Committee to support these arrangements. This would of course include those regulators that are public bodies.

Equalities and fairness bodies

A number of reforms are proposed to bodies that have a remit in support of equalities or fairness issues. It is important that the broader rationale for

these reforms is clearly articulated, and a proposed narrative is included in Annex C.

Charities

A small number of bodies within the review are established charities, and where changes to the status of a charity are under consideration you are asked to seek and consider specific legal advice on how reforms can be handled for that particular body.

It is generally understood that NDPB status can be removed if the organisation intends to continue its charitable function as before, but with independence from Government.

The Public Bodies Bill

Where primary legislation is required, the Public Bodies Bill will provide the statutory framework for effecting the changes agreed through the Public Bodies review process. It will not be the only legislative vehicle: where it is more appropriate, some of the agreed reforms will have their legislative underpinnings in departmental bills that help set the changes in context. The Public Bodies Bill is scheduled for introduction in the week commencing the 18 October 2010 with the aim of achieving Royal Assent by summer 2011. Clearance from the Parliamentary Business and Legislation Committee will be sought for the final Bill and all accompanying documentation prior to introduction.

I would like to ask colleagues for their help in agreeing reforms as soon as possible in order that they can be included in the Bill where this is necessary.

Implementation

For some departments the reforms set out in this paper will have a significant impact on the public sector landscape and will require extensive implementation planning. It is the responsibility of departments to undertake their own implementation work, although the Efficiency and Reform Group is supporting this by arranging some cross-departmental networks to enable sharing of expertise and is developing some guiding principles on effective management of staffing issues and disposal of assets.

My officials are working with yours on implementation, and have asked for outline plans to be submitted to Cabinet Office during September. We will also be asking departments to undertake impact assessments for their own reforms, including the impact of changes to work volume or demand, and feed into our broader impact assessment for the Public Bodies Bill. I would like to ask colleagues for their assurance that they have the governance arrangements and the resources in place to achieve this.

Reductions in staff numbers and other winding-up measures will have associated costs, and departments will be expected to meet these from within the settlement they agree as part of the Spending Review. My officials will work with yours and with HM Treasury in the run up to the Spending Review to look at the financial impact of the reforms.

Ongoing governance and review

Alongside the package of reforms set out in this paper, I am also strengthening the Government's ongoing monitoring and review requirements for public bodies to ensure that we have more robust controls on their creation and retention in future. This will ensure that we continue to make the public bodies sector more transparent and accountable. Further details can be found in Annex C.
